## Club Information 2022-2023 Season

### 18's, 17's, 16's, 15s TRAVEL Team Fees      **\$4,200**

- Practices / Scrimmages **three** times per week & **two** per week when teams have a weekend tournament scheduled & during the Holidays season (Dec & Jan).
- Regular season Fees are from November 2022 through end of regular season 2023 (PVL or SCVA So Cal).
- Age group workouts and selected clinics; gym & coaching fees for regular season team practices.
- Entry & Coaching Fees for Holiday Tournament, 2-SCVA Qualifying, 2-SCVA Mandatories, and SCVA So. Cal Championships or 9-10 tournaments days for PVL.
- Player Uniform Packages include: 3 Practice T-Shirts; 3 jerseys, spandex, warm-ups, and player backpack.
- College Recruiting Assistance.

### 14s, 13s, 12's TRAVEL Team Fees      **\$4,000**

- Practices / Scrimmages **three** times per week & **two** per week when teams have a weekend tournament scheduled & during the Holidays season (Dec & Jan).
- Regular season fees are from November 2022 through end of regular season 2023 (PVL or SCVA So Cal).
- Age group workouts and selected clinics; gym & coaching fees for regular season team practices.
- Entry & Coaching Fees for Holiday Tournament, 2-SCVA Qualifying, 2-SCVA Mandatories, and SCVA So Cal Championships or 9-10 tournament days for PVL.
- Player Uniform Packages include: 3 Practice T-Shirts; 3 jerseys, spandex, warm-ups, and player backpack.

### 14's, 13's, 12's and 11's REGIONAL Team Fees      **\$3,300**

- Practices / Scrimmages **two** times per week & **one** per week when teams have a weekend tournament scheduled & during the Holidays season (Dec & Jan).
- Regular season fees are from November 2021 through end of regular season 2023 (PVL or SCVA So Cal).
- Age group workouts and selected clinics; gym & coaching fees for regular season team practices.
- Entry & Coaching Fees for Holiday Tournament, 2-SCVA Qualifying, 2-Mandatories, and SCVA So Cal.
- Player Uniform Packages include: 3 Practice T-Shirts; 2 jerseys, spandex, warm-ups, and player backpack.

### Available Discounts:

- \$100 Returning Player from the 2021/22 Season
  - *(ONLY available if deposit is paid in full deposit on Commitment Night)*
- \$100 Season Fees Payment in Full Discount
  - *(ONLY available if paid in full on Commitment Night)*
- \$250 Siblings Discount
  - *(for second/third sibling – discount taken off younger sibling - one per family)*

## **Travel Team Optional & Post Season Tournaments:**

Travel Teams will evaluate and assess conditions to attend any travel tournaments such as Jr National Qualifiers (JNQs) and other travel tournaments such as Las Vegas Classic, Triple Crown, AAU, JVA and any post season tournaments. The club will decide IF IT IS REASONBLE and SAFE TO TRAVEL to any of these tournaments and will communicate to those teams on how to plan and budget for them. Each Travel Team will conduct parent / player information meetings with their team's coach & club staff to discuss invitational & qualifying tournaments priorities based on their SCVA/PVL age group schedules to determine which additional events they can attend. The Board of Directors will make the FINAL decision in determining which tournaments teams will attend. Once the priorities are determined additional fees will be assessed for entry & coaching fees / expenses. Several events now have a stay & play policy where teams are required to book their housing with approved sites.

## **Tournaments & Events:**

The 2022-2023 SCVA/PVL Girls' Tournament Schedule for each age group will be posted on the SCVA & PVL websites. **Teams playing in the PVL schedule will have an additional \$50 player's fee when playing on a SCVA tournament if required to qualify for the SCVA Bid Tournament.**

- There are separate age level SCVA/PVL division tournaments for the 18's, 17's, 16's; 15's; 14's; 13's; and 12 & under teams.
- **Optional Tournaments:** Optional tournaments / travel fees will be discussed with each team in October, November or December. Optional tournaments include the USAV Jr. National Qualifiers in other USAV Regions; SCVA Classic Tournament; SCVA Regional Bid Tournament; PVL Invitational Tournaments; and Triple Crown/JVA/AAU Showcase Tournaments that are now being scheduled around the country for each age division.
- **Post Season Girls' Events:** These events will be discussed with each travel teams' players / parents in November / December to determine their team's options for [bid or invitational events] event dates, & entry deadlines, and projected associated fees.

- 2023 USAV 11s-13s Girls' Junior National Championships – Minneapolis, MN (11-13 June)

- 2023 AAU Girls' Volleyball Festival Championships – in Phoenix, AZ (June)

## **2022-2023 SCVA Commitment & Non-Refundable Deposit Due Dates**

15 - 18's team: Commitment and \$700 Deposit due July 26, 2022

11 – 14's team: Commitment and \$700 Deposit due October 4, 2022

**Payment Plan for 2022-2023 Season:**

Due to still some unknowns for this upcoming season, we will continue with our “pay as you go” approach where dues/fees will be charged the 1<sup>st</sup> of every other month (except October) while in season. Once this bi-monthly training payment is done (every 2 months), it becomes non-refundable unless Covid-19 restricts or prohibits the continuation of training. Any Covid-19 refund for training will be prorated based on the number of practices remaining on the 2-month period.

Below is the Payment Plan for TRAINING and LOCAL TOURNAMENTS:

- **18’s thru 15’s TRAVEL Team SEASON FEE – \$ 3,500 (after \$700 non-refundable deposit)**

**NOTE:** SCVA/PVL TOURNAMENT(s) Players Fee’s are \$50 per tournament. A total of 9-10 tournaments days are scheduled for the regular season. Only 9-10 tournaments days are included in the season fee. If additional tournaments are played, a fee of \$50 per tournament per day will be charged to your account. Travel tournaments (i.e., PVL MLK, PVL/JVA Cup, Las Vegas Classic, Triple Crown, JNQs, JNs, JVA, AAU, etc.) are NOT included in the “season fees”. Amounts and due dates are TBD and determined by a team budget and charged for separately. **The SCVA Regional Bid Tournament is NOT included in the “season fees”.**

Please note that there is a quick reference payment schedule at the back of this package for future reference.

**Account Billing & Statements:**

Our club will email monthly statements / payment reminders to parents when fees are due.
